Thank you for your interest in renting space at the Stoughton Fairgrounds. In an effort to serve you better, we ask that you fill out **BOTH** pages of the rental agreement before you arrive at the fairgrounds (Mandt Park). We also ask that you bring a check for the entire amount with the forms when you store your property. Rent for the 2009-2010 storage season (October-April) will be as follows:

Property under 20 feet	\$160.00
Property 20 to 25 feet	\$195.00
Property over 25 feet	\$235.00
Cars on concrete	\$210.00
Motorcycle	\$135.00

Footage is measured from the longest point overall-example: hitch to prop.

The date to move in property is the **third** Saturday in October (**October 17, 2009**), between **8:00 AM and 11:00 AM** at the Fairgrounds, Mandt Park. Property not arriving during that time be assessed an "early in" or "late in" fee of \$25.00 which is payable with your rental. Please make check payable to the Stoughton Fair. The removal date is the **third** Saturday in April (**April 17, 2010**). A notice will be mailed as a reminder.
