Thank you for your interest in renting space at the Stoughton Fairgrounds.

Rent for the 2026-2027 storage season (October-April) will be as follows:

Property under 20 feet	\$310.00
Property 20 to 25 feet	\$385.00
Property over 25 feet	\$460.00
Cars on concrete	\$385.00
Motorcycle/ATV/UTV	\$310.00

** Footage is measured from the longest point, overall. (example: hitch to prop)*

Please fill out **BOTH** pages of this rental agreement before you arrive at the fairgrounds (Mandt Park) on move-in day. Bring your check for the entire amount, with the completed forms when you arrive to store your property.

- Property move-in is the **third** Saturday in October (**October 17, 2026**), between **8:00 AM and 10:00 AM** at the Fairgrounds, Mandt Park. Move-in is first come, first serve. A map will be published on our website prior to move-in day to illustrate where the line will form. Property will be moved into place by our volunteers to maximize capacity.
- Property move-out is the **third** Saturday in April (**April 17, 2027**), you may retrieve your property from the grounds **after 8 a.m.** that morning. Property will be moved out of storage by our volunteers and placed around the grounds for you.

One (1) early move-in date and one late move-out date will be offered for an additional \$100 fee (fee assessed for each date). You must contact us by email to request early move-in or late move-out.
