Thank you for your interest in renting space at the Stoughton Fairgrounds. In an effort to serve you better, we ask that you fill out **BOTH** pages of this rental agreement before you arrive at the fairgrounds (Mandt Park). Please bring a check for the entire amount with the completed forms when you arrive to store your property.

Rent for the 2025-2026 storage season (October-April) will be as follows:

Property under 20 feet	\$310.00
Property 20 to 25 feet	\$385.00
Property over 25 feet	\$460.00
Cars on concrete	\$385.00
Motorcycle/ATV/UTV	\$310.00

Footage is measured from the longest point, overall. (example: hitch to prop)

Property move-in is the **third** Saturday in October (**October 18, 2025**), between **8:00 AM and 10:00 AM** at the Fairgrounds, Mandt Park. Property removal date is the **third** Saturday in April (**April 18, 2026**), you may retrieve your property from the grounds after 10 a.m. that morning.

If you are unable to be available on one or both of these dates, one early move-in and late move-out date will be offered for an additional \$100 fee (fee assessed for each date).

Please make a check payable to the Stoughton Fair.

A notice will be emailed as a reminder; we no longer send postcard reminders.
