Thank you for your interest in renting space at the Stoughton Fairgrounds. In an effort to serve you better, we ask that you fill out **BOTH** pages of this rental agreement before you arrive at the fairgrounds (Mandt Park). Please bring a check for the entire amount with the completed forms when you arrive to store your property.

Rent for the 2023-2024 storage season (October-April) will be as follows:

Property under 20 feet	\$300.00
Property 20 to 25 feet	\$375.00
Property over 25 feet	\$450.00
Cars on concrete	\$375.00
Motorcycle/ATV/UTV	\$300.00

Footage is measured from the longest point overall-example: hitch to prop.

The date to move in property is the **third** Saturday in October (**October 21, 2023**), between **8:00 AM and 10:00 AM** at the Fairgrounds, Mandt Park. Property not arriving during that time will be assessed an “early in” or “late in” fee of \$25.00 which is payable with your rental. Please make a check payable to the Stoughton Fair. The removal date is the **third** Saturday in April (**April 20, 2023**). A notice will be emailed as a reminder; we no longer send postcard reminders. There will be a “late out” fee of \$50 charged.
