Thank you for your interest in renting space at the Stoughton Fairgrounds. In an effort to serve you better, we ask that you fill out **BOTH** pages of this rental agreement before you arrive at the fairgrounds (Mandt Park). Please bring a check for the entire amount with the completed forms when you arrive to store your property.

Rent for the 2024-2025 storage season (October-April) will be as follows:

Property under 20 feet	\$300.00
Property 20 to 25 feet	\$375.00
Property over 25 feet	\$450.00
Cars on concrete	\$375.00
Motorcycle/ATV/UTV	\$300.00

Footage is measured from the longest point overall-example: hitch to prop.

Property move-in is the **third** Saturday in October (**October 19, 2024**), between **8:00 AM and 10:00 AM** at the Fairgrounds, Mandt Park. Property removal date is the **fourth** Saturday in April (**April 26, 2024**).

If you are unable to be available on one or both of these dates, early move-in (10/5/2024) and late move-out (5/3/2025) dates are available for a \$100 fee (fee assessed for each date).

A notice will be emailed as a reminder; we no longer send postcard reminders.
